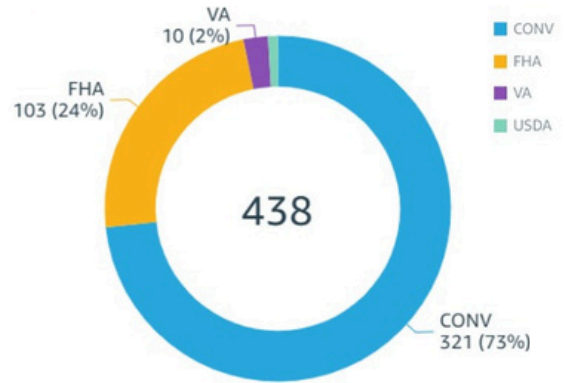

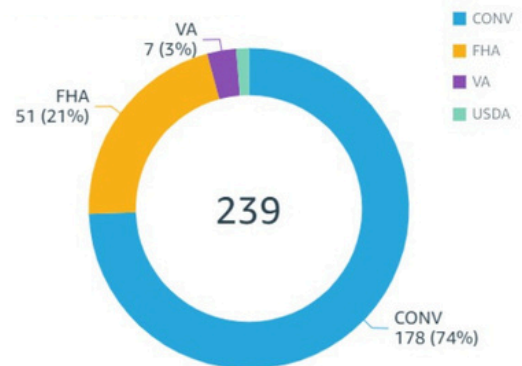

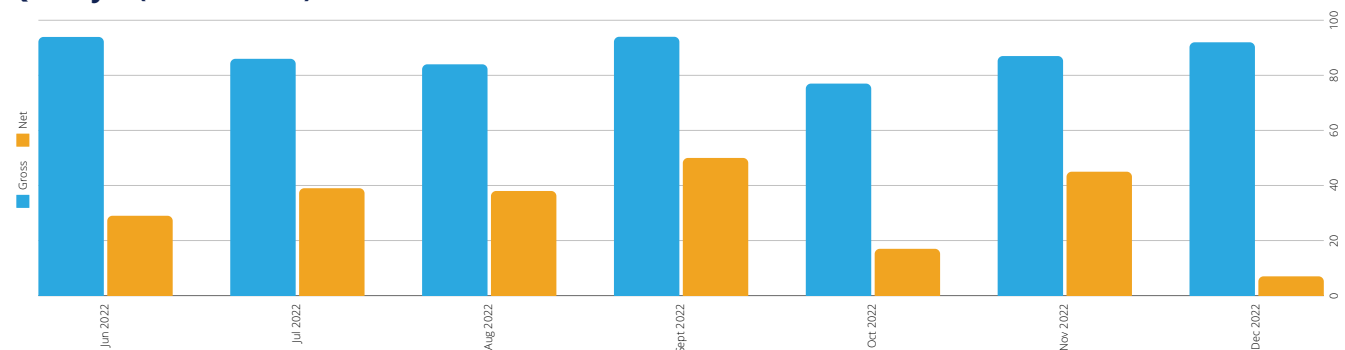
### Demo LLC PC Blended Model:

The Quality Control Team Provided a list of **807** number of loans that were closed between selected dates. A total **314** were selected for review which represents a sample of **38.91%**.

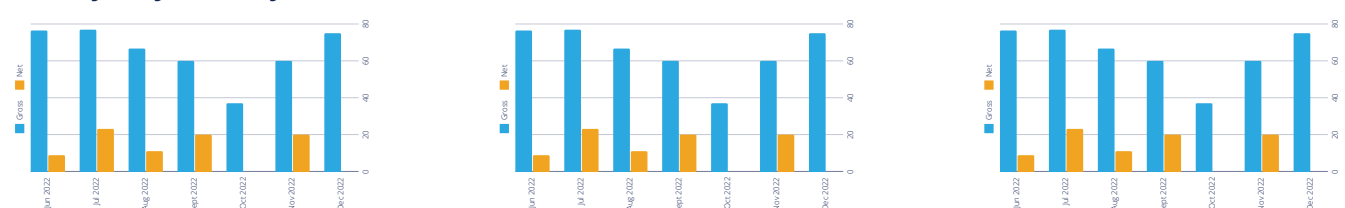
**Gross:** After audit of **314** total loans selected for Audit, a total of **438** Gross exceptions were noted. **71** Significant exceptions, **266** Moderate exceptions and **101** Minor Exceptions and **0** Observations are noted.

**Net:** After audit of **314** total loans selected for Audit, a total of **107** Net exceptions were noted. **11** Significant exceptions, **55** Moderate exceptions, **41** Minor Exceptions and **0** Observations are noted.
